In 2011, Kathy was named one of Newsweek's "150 Women Who Rock the World," and in 2012, she was listed in Fast Company's "League of Extraordinary Women." Her innovative work in the philanthropy and international NGO sector was featured by the [New York Times](#) in 2011. She has received numerous other awards for philanthropy and leadership.

Prior to joining the UN Foundation as Chief Operating Officer in 2003, Kathy served as President of the AOL Time Warner Foundation where she guided AOL Time Warner's philanthropic activities and was the chief architect of the company's corporate responsibility initiatives. She joined America Online in 1997 as Senior Vice President and Chief Communications Officer, and was responsible for the company's brand, social responsibility, and external relations.

Immediately prior to joining AOL, she was a Senior Managing Director at Hill and Knowlton, a global public relations company, where she led the U.S. Media Relations practice. For 12 years before that, she served as Director of Editorial Administration for U.S. News & World Report, overseeing budget, personnel, innovation and strategy. From 1976 through 1984, Kathy served as Senator Gary Hart's press secretary in his Senate office and his 1984 Presidential campaign. She was one of the first women to hold that title in American Presidential campaigns.

Throughout her career, Kathy Calvin has taken an active role in a range of philanthropic activities, including the boards of the International Women's Media Foundation, City Year, Internews, the Newseum, Share Our Strength, the United Nations Association of the United States of America, and the East-West Center. She is a frequent public speaker and commenter.

Prior to his appointment as Secretary-General, Mr. Guterres served as United Nations High Commissioner for Refugees from June 2005 to December 2015, heading one of the world's foremost humanitarian organizations during some of the most serious displacement crises in decades. The conflicts in Syria and Iraq, and the crises in South Sudan, the Central African Republic and Yemen, led to a huge rise in UNHCR's activities as the number of people displaced by conflict and persecution rose from 38 million in 2005 to over 60 million in 2015.

Before joining UNHCR, Mr. Guterres spent more than 20 years in government and public service. He served as prime minister of Portugal from 1995 to 2002, during which time he was heavily involved in the international effort to resolve the crisis in East Timor.

As president of the European Council in early 2000, he led the adoption of the Lisbon Agenda for growth and jobs, and co-chaired the first European Union-Africa summit. He was a member of the Portuguese Council of State from 1991 to 2002.

Mr. Guterres was elected to the Portuguese Parliament in 1976 where he served as a member for 17 years. During that time, he chaired the Parliamentary Committee for Economy, Finance and Planning, and later the Parliamentary Committee for Territorial Administration, Municipalities and Environment. He was also leader of his party's parliamentary group.

From 1981 to 1983, Mr. Guterres was a member of the Parliamentary Assembly of the Council of Europe, where he chaired the Committee on Demography, Migration and Refugees.

For many years Mr. Guterres was active in the Socialist International, a worldwide organization of social democratic political parties. He was the group's vice-president from 1992 to 1999, co-chairing the African Committee and later the Development Committee. He served as President from 1999 until mid-2005. In addition, he founded the Portuguese Refugee Council as well as the Portuguese Consumers Association DECO, and served as president of the Centro de Acção Social Universitário, an association carrying out social development projects in poor neighborhoods of Lisbon, in the early 1970s.

Mr. Guterres is a member of the Club of Madrid, a leadership alliance of democratic former presidents and prime ministers from around the world.

Mr. Guterres was born in Lisbon in 1949 and graduated from the Instituto Superior Técnico with a degree in engineering. He is fluent in Portuguese, English, French and Spanish. He is married to Catarina de Almeida Vaz Pinto, Deputy Mayor for Culture of Lisbon, and has two children, a stepson and three grandchildren.

As President of the Better World Campaign, Peter Yeo leads the Campaign's strategic engagement with Congress and the Administration to promote a strong U.S.-UN relationship. Under Yeo's leadership, the Better World Campaign has helped ensure multibillion-dollar payments from the U.S. government to the UN. Yeo also serves as the Senior Vice President at the United Nations Foundation.

Yeo joined the Better World Campaign in 2009 with over twenty years of legislative, analytical, and management experience, including senior roles on Capitol Hill and in the State Department. Prior to arriving at UNF, Yeo served for ten years as the Deputy Staff Director at the House Foreign Affairs Committee chaired by Rep. Tom Lantos (D-CA) and Rep. Howard Berman (D-CA). He has worked on a broad range of foreign policy and foreign aid issues. On behalf of the House Foreign Affairs Committee Democrats, he led the successful negotiations for the landmark HIV/AIDS, Tuberculosis and Malaria Act of 2003, commonly known as PEPFAR, as well as the successful \$50 billion reauthorization of the law in 2008.

He also shepherded into law several measures dealing with China, Tibet, Burma, and East Timor. Prior to his work with the Committee, he served as a Deputy Assistant Secretary at the U.S. State Department during the second Clinton Administration, where he led the negotiations around repayment of the U.S. arrears to the United Nations and was part of the U.S. delegation to the climate negotiations in Kyoto. Yeo holds a BA in East Asian Studies from Wesleyan University as well as a MA in East Asian Studies from Harvard University. He is also a member of the Council on Foreign Relations, a leading independent nonpartisan foreign policy think tank, and a Board Member of the U.S. Global Leadership Coalition.

Congressman Engel was born in the Bronx on February 18, 1947. He grew up in a city housing project and attended New York City public schools. In 1969, he graduated from Hunter-Lehman College with a B.A. in History and received a Master's Degree in Guidance and Counseling in 1973 from Herbert H. Lehman College of the City University of New York. In 1987, he received a law degree from New York Law School.

For twelve years prior to his election to Congress, Mr. Engel served in the New York State Assembly (1977-1988), where he chaired the Committee on Alcoholism and Substance Abuse, as well as the Subcommittee on Mitchell-Lama Housing. Prior to that, he was a teacher and guidance counselor in the New York City public school system. A lifelong resident of the Bronx, Congressman Engel is married to Pat Engel. They have three children.

Ambassador Jonathan Cohen became Acting Permanent Representative of the United States to the United Nations on January 2, 2019, after having been the Deputy Permanent Representative since June 8, 2018. From August 2016 until June 2018, he served as Deputy Assistant Secretary of State for European and Eurasian

Affairs covering Cyprus, Greece and Turkey. He served in Baghdad as Deputy Chief of Mission 2014-2016, in Paris as Acting Deputy Chief of Mission 2013-2014 and as Minister Counselor for Political Affairs 2011-2013. From 2008-2011 he was Deputy Chief of Mission in Nicosia. From 2004-2008 he was Counselor for Political-Military Affairs in Rome. From providing humanitarian assistance to investigating human rights abuses and advancing delicate diplomatic negotiations, the UN has played a myriad of roles to address the deadly conflict in Yemen. In December 2018, there was a breakthrough when the UN Security Council passed its first comprehensive resolution on the conflict in three years. Adopted by consensus, the document endorsed a limited cease-fire reached by parties with UN backing. It also called for the deployment of a monitoring mission on the ground. presidential elections to the Haiti earthquake, global health security in the Horn of Africa to green energy investments in California. More recently, Mirchandani has helped the Center for Global Development navigate a redrawn political map, bringing the substance and relevance of the Center's pioneering economics research to wider audiences. On a wide range of issues, he has helped bring hard evidence to heated political debates at a time when power and influence in the world are shifting, attention spans are shrinking, and the traditional consensus around international cooperation is fraying.

In 2012, Mirchandani was awarded a graduate degree in public diplomacy from the University of Southern California in Los Angeles. Over the years, he has been a frequent collaborator of the UN as a moderator and commentator.

Karen joined the Foreign & Commonwealth Office in 1981. Her first role was in Tokyo between 1984 and 1987, after which she returned to the UK to work in the Security Policy Department. Karen worked in Washington as the Private Secretary to the British Ambassador to the United States between 1992 and 1995. Between 1996 and 2006, Karen held several positions in London including Team Leader for Ukraine, Belarus and Moldova, Deputy Head of Eastern Adriatic (Balkans) Department, Head of Newsroom, Head of EU Department (Bilateral) and concurrently Head of Afghanistan Political Military Unit after 9/11 before returning to the Balkans as Balkans Coordinator from 2002 to 2006.

In 2006, Karen moved to New York for the first time to be the Deputy Permanent Representative and Ambassador at the UK Mission to the UN. In 2009, she returned to London to become the Director of South Asia and Afghanistan Department and the UK's Special Representative for Afghanistan and Pakistan. In 2012, Karen started her second multilateral role, this time in Geneva, where she was the Ambassador and Permanent Representative to the UK Mission to the United Nations, World Trade Organization and Other International Organizations until 2015. Louis Charbonneau is the United Nations director at Human Rights Watch. Prior to joining HRW, he was a journalist for more than two decades, most recently U.N. bureau chief for Reuters. In addition to his work from the United Nations in New York, he has reported from dozens of countries in Europe, Asia and Africa and spent years doing investigative work on issues related to the Middle East and Africa. Louis was previously posted in Prague, Hong Kong, Vienna and Berlin. His first posting with Reuters was in Vienna, where he focused on the IAEA and other U.N. agencies from 2001 to 2005.

He was Reuters' deputy bureau chief in Berlin from 2005 to 2008. Starting in early 2008 he was based at Reuters bureau inside United Nations headquarters in New York, where he followed the Security Council, General Assembly and other U.N. bodies. He was a two-time winner of the Elizabeth Neuffer Memorial award for his U.N. reporting (2009 and 2011), as well as the United Nations Foundation Prize for his coverage of negotiations on an Arms Trade Treaty (2013).

During his time in Vienna, Louis became an expert on nonproliferation and nuclear issues. He covered the U.N. weapons inspections in Iraq in 2002-03 and the IAEA's attempts to resolve the nuclear crises in North Korea and Iran. In New York, he expanded his U.N. coverage to include human rights and other topics.

He began his journalism career in 1991 with an editorial internship on the theater desk at the Village Voice. After relocating to Prague in 1992, he began covering culture and politics in post-communist

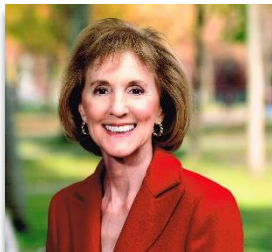

Tim Weiskel graduated magnum cum laude from Yale University. He trained as a social anthropologist and an historian as a Rhodes Scholar at Balliol College, Oxford and the École Pratique des Hautes Études in Paris. Following field work in West Africa he received his D.Phil. from Oxford University and returned to the

United States to teach anthropology and history at Williams College, Yale University and Harvard.

For the last several decades he has focused upon the environmental ethics and environmental justice of global climate change. The crisis of climate change represents the most daunting problem the human community has ever faced in the course of its history as a species on Earth. In the last several centuries, human communities have come to depend for their energy supplies upon a pattern of consumption of non-renewable, fossilized carbon in the form of coal, petroleum and natural gas.

In addition to becoming more scarce and more expensive to extract, fossil fuel dependence represents another -- potentially catastrophic -- problem for the human civilization. The accelerated use of these fuels has enabled parts of the world to industrialize their economies, but in the process this combustion of terrestrial carbon has provoked a dangerous destabilization of the enduring climate regime that Earth experienced throughout the Holocene for the last 10,000 to 12,000 years. All of recorded human history, from the dawn of agriculture through to the "space age" has developed within this relatively stable geological period of climate history.

Now, however, because of the massive release of carbon into the atmosphere as a result of industrial processes and a altered relationships to forest and agricultural land, humankind needs to prepare for disruptive and potentially abrupt shifts in climate, extreme weather and global sea-level rise on a scale never before experienced in human history. New forms of partnering are now urgently required across all national barriers, language traditions, economic systems and political regimes if human civilization is to be able to survive.

Professor Weiskel is now concentrating his research and online teaching to achieve this vital transition through transitionstudies.net

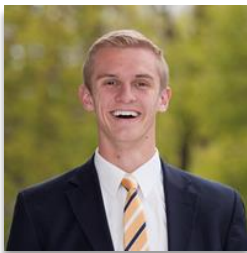

On 5 June 2018, the United Nations General Assembly elected Ecuadorean Foreign Minister María Fernanda Espinosa Garcés, as President of its 73rd session; only the fourth woman to hold that position in the history of the world body, and the first since 2006.

The President of the seventy-third session of the General Assembly, María Fernanda Espinosa Garcés, has more than 20 years of multilateral experience in international negotiations, peace, security, defence, disarmament, human rights, indigenous peoples, gender equality, sustainable development, environment, biodiversity, climate change and multilateral cooperation. She has served Ecuador as Minister of Foreign Affairs (twice), Minister of National Defence, and Coordinating Minister of Natural and Cultural Heritage.

In those capacities she coordinated the Sectorial Council on Foreign Policy and Promotion, which includes the Ministries of Tourism, Culture and Heritage, Foreign Trade, and the Environment. Ms. Espinosa Garcés was Chair of the Group of 77 and China until January 2018, and also served as Chair of the Andean Community. At the fifty-sixth session of the Commission on the Status of Women, she promoted the adoption of the resolution presented by Ecuador entitled "Indigenous women: key actors in poverty and hunger eradication". She was a chief negotiator at the sixteenth and seventeenth Conferences of the Parties of the United Nations Framework Convention on Climate Change and at the Rio+20 United Nations Conference on Sustainable Development, where she facilitated the adoption of key elements in the outcome document entitled "The future we want".

As Minister of National Defence of Ecuador, Ms. Espinosa Garcés participated in debates on women, peace and security, and promoted the creation of the South American Defence School of the Union of South American Nations, among other initiatives.

In 2008, she was the first woman to become Permanent Representative of Ecuador to the United Nations in New York. During that posting, she cofacilitated the Working Group on the revitalization of the work of the General Assembly at its sixty-third session. She also led efforts at the global level towards the achievement of the Millennium Development Goals.

As Permanent Representative to the United Nations in Geneva, she led and supported various negotiation processes at the Human Rights Council. She chaired the work of the Community of Latin American and Caribbean States (CELAC) in Geneva, and at the twenty-first Conference of the Parties (COP 21) on Climate Change in Paris.

Ms. Espinosa Garcés was Special Adviser to the President of the Constituent Assembly that drafted the Constitution of Ecuador in 2008 and Regional Director (South America) and Adviser on Biodiversity (Geneva) at the International Union for Conservation of Nature. In both positions, she worked for approximately 10 years on various initiatives at WIPO and WTO; participated in negotiations on intellectual property, and traditional and ancestral knowledge; and supported the Andean Community and the Amazon Cooperation Treaty Organization on strategic management and sustainable development.

Before beginning her political and diplomatic career, Ms. Espinosa Garcés was Associate Professor and Researcher at the Facultad Latinoamericana de Ciencias Sociales Sede Ecuador. During her time in academia, she received scholarships and grants from the Latin American Studies Association, the Ford Foundation, the Society of Woman Geographers and the Rockefeller Foundation towards her research in the Amazon. She also received awards from the German Agency for Cooperation, Deutsche Gesellschaft für Technische Zusammenarbeit (GTZ) and Natura Foundation for her research work.

Ms. Espinosa Garcés has written over 30 academic articles about the Amazon region, culture, heritage, sustainable development, climate change, intellectual property, foreign policy, regional integration, defence and security. She has studies from Rutgers University. She holds a master's degree in social sciences and Amazonian studies and a postgraduate diploma in anthropology and political science from the Facultad Latinoamericana de Ciencias Sociales Sede Ecuador, as well as a bachelor's degree in applied linguistics from the Pontificia Universidad Católica del Ecuador.
