<p>H.R.2116 - Global Fragility Act</p> <p>Passed House: 05/20/2019</p>	<p>This bill directs the Department of State to establish the interagency Global Fragility Initiative to stabilize conflict-affected areas and prevent violence globally and establishes funds to support such efforts.</p> <p>The State Department shall devise a plan for the initiative, including its organizational structure and goals. The State Department shall lead in foreign policy, diplomatic, and political efforts. The U.S. Agency for International Development shall lead in development, humanitarian, and non-security policies. Other departments and agencies, including the Department of Defense, shall provide support as necessary.</p> <p>The State Department shall select priority countries and regions that are particularly at risk, and report to Congress 10-year plans for each. Each plan shall include information including descriptions of goals, plans for reaching such goals, and benchmarks for measuring progress.</p> <p>The State Department shall report to Congress every two years about the initiative's progress. The Government Accountability Office shall consult Congress every two years about opportunities to assess the initiative and recommend improvements.</p> <p>The bill creates the Stabilization and Prevention Fund to support efforts to stabilize conflict-affected areas, including areas at risk from the Islamic State of Iraq and Syria or other terrorist organizations.</p> <p>The bill establishes the Complex Crises Fund to support programs to address emerging, unforeseen, or complex challenges abroad.</p>
<p>H.R.3460 - End Neglected Tropical Diseases Act</p> <p>Passed House: 12/03/2019</p>	<p>This bill states that it is U.S. policy to support a broad range of activities toward finding cost-effective treatment for, and eliminating, neglected tropical diseases in order to improve the economic and social well-being of all people.</p> <p>The bill defines neglected tropical diseases as those that disproportionately impact individuals living in extreme poverty, especially in developing countries, and includes Chagas disease, dengue fever, and leprosy.</p>
<p>H.R.2153 - Keeping Girls in School Act</p> <p>Passed House: 01/28/2020</p>	<p>This bill authorizes the U.S. Agency for International Development (USAID) to enter into acquisition, assistance, or financing agreements to address societal, cultural, health, and other barriers that adolescent girls face in accessing quality secondary education.</p> <p>The USAID shall seek to ensure that such activities meet various requirements related to monitoring and evaluating outcomes, collecting data, and adhering to gender-equality promotion policies.</p> <p>The Department of State shall periodically update and report to Congress a publicly available U.S. global strategy to empower adolescent girls. The U.S. Global Strategy to Empower Adolescent Girls, issued in March 2016, may serve as the initial version of the strategy. The USAID shall periodically report to Congress on the activities initiated under this bill and efforts to monitor and evaluate such activities.</p>



<p>H.R.9 - Climate Action Now Act Passed House (05/02/2019)</p>	<p>This bill requires the President to develop and update annually a plan for the United States to meet its nationally determined contribution under the Paris Agreement on climate change.</p> <p>(Sec. 3) In addition, the bill prohibits federal funds from being used to withdraw from the agreement.</p> <p>(Sec. 4) The bill outlines what must be included in the plan, including descriptions of steps to (1) cut greenhouse gas emissions by 26%-28% below 2005 levels by 2025, and (2) confirm that other parties to the agreement with major economies are fulfilling their announced contributions. The President must seek and publish comments from the public when submitting and updating the plan.</p> <p>(Sec. 5) Within six months, the President must report on the effect of the Paris Agreement on clean energy job development in rural communities.</p> <p>(Sec. 6) Within six months, the President must also contract with the National Academy of Sciences to report on the potential impacts of a withdrawal by the United States from the agreement on the global economic competitiveness of the U.S. economy and on U.S. workers.</p> <p>(Sec. 8) Within one year, the Government Accountability Office must study and report on the impact of the plan on U.S. territories.</p>
<p>H.RES.387 - Condemning continued violence against civilians by armed groups in the Central African Republic Passed House (05/16/2019)</p>	<p>This resolution condemns violence against civilians in the Central African Republic and expresses support for efforts to combat the threat posed by armed groups. The resolution also urges relevant federal departments and agencies to provide humanitarian assistance to these civilians and take steps to prioritize a stronger partnership between the United States and the Central African Republic.</p>
<p>House Foreign Affairs Committee / Senate Foreign Relations Committee</p>	<p>The United States House Committee on Foreign Affairs and the Senate Committee on Foreign Relations has jurisdiction over bills and investigations related to the foreign affairs of the United States. The Members of Congress in these committees work very closely with international partners, including figures within the UN system.</p>
<p>House / Senate Appropriations Committee</p>	<p>The Committee on Appropriations is responsible for passing appropriation / funding bills alongside the Senate. The bills passed by the Appropriations Committee regulate expenditures of money by the government of the United States, including U.S. funding for international programs, like the UN. As such, it is one of the most powerful of the committees, and its members are seen as vitally influential.</p>

<p>S.727- Global Fragility Act</p> <p>Reported to Senate: 07/18/2019</p>	<p>This bill directs the President to devise and implement a plan to combat global fragility. The bill also establishes funds to support such endeavors.</p> <p>The President shall report to Congress and implement a 10-year Global Fragility Strategy to (1) help stabilize conflict-affected areas, (2) address global fragility, and (3) increase U.S. capacity to be a leader in international efforts to prevent extremism and violent conflict. The strategy shall (1) focus on the long-term causes of fragility and violence; (2) include specific objectives and approaches to reduce such causes; and (3) contain a selection of priority countries and regions based on various factors, including U.S. national security interest and clearly defined indicators of the levels of violence or fragility in a country or region. The President shall report to Congress and implement action plans for the priority countries and regions.</p> <p>The bill establishes the Prevention and Stabilization Fund to replace the Relief and Recovery Fund. The new fund shall support stabilization of conflict-affected areas and assist areas liberated from or at risk from various terrorist organizations such as the Islamic State of Iraq and Syria. The bill also establishes the Complex Crises Fund to prevent or respond to emerging and unforeseen events overseas.</p>
<p>S.2481- End Neglected Tropical Diseases Act</p> <p>Introduced in Senate: 09/17/2019</p>	<p>This bill states that it is U.S. policy to support a broad range of activities toward finding cost-effective treatment for, and eliminating, neglected tropical diseases in order to improve the economic and social well-being of all people.</p> <p>The bill defines neglected tropical diseases as those that disproportionately impact individuals living in extreme poverty, especially in developing countries, and includes Chagas disease, dengue fever, and leprosy.</p>
<p>S.1071- Keeping Girls in School Act</p> <p>Introduced in Senate: 04/09/2019</p>	<p>This bill authorizes the U.S. Agency for International Development (USAID) to enter into acquisition, assistance, or financing agreements to address societal, cultural, health, and other barriers that adolescent girls face in accessing quality secondary education.</p> <p>The USAID shall seek to ensure that such activities meet various requirements related to monitoring and evaluating outcomes, collecting data, and adhering to gender-equality promotion policies.</p> <p>The Department of State shall periodically update and report to Congress a publicly available U.S. global strategy to empower adolescent girls. The U.S. Global Strategy to Empower Adolescent Girls, issued in March 2016, may serve as the initial version of the strategy. The USAID shall periodically report to Congress on the activities initiated under this bill and efforts to monitor and evaluate such activities.</p>
<p>S.1743 - International Climate Accountability Act</p> <p>Introduced in Senate: 06/05/2019</p>	<p>This bill prohibits implementation of the U.S. withdrawal from the Paris Agreement, the United Nations agreement to address climate change adopted December 12, 2015. The President shall annually report to Congress a plan for how the United States will achieve its goals to reduce greenhouse gases under the agreement.</p>
