



## **Global Goals Ambassador Monthly Report**

As the United Nations Association's Global Goals Ambassador for SDG 10, I am committed to reducing intersectional inequalities and promoting cultures of inclusion for all. This month, I had the pleasure of connecting these objectives through my work on the Coalition for the UN We Need's Media and Information Service, live coverage of the United Nations' Summit of the Future Action Days, Summit of the Future, and the People's Assembly, and my live speaking engagements.

### **A. C4UN Media and Information Service**



As a Communications Associate for the Coalition for the UN We Need, I supported the planning and on-the-ground logistics for the Coalition for the UN We Need's Media and Information Service, which aimed to connect journalists with the Summit of the Future. This helped generate wider media coverage, ensuring the public was informed about the crucial discussions shaping the future of global governance.

The Coalition for the UN We Need's Media and Information Hub proved to be a crucial tool in the effort to reduce inequality during the Summit of the Future and its Action Days. By providing live coverage and connecting journalists to critical discussions at the UN, the Hub successfully made the UN's high-level processes more transparent and accessible to a wider audience. This accessibility played a key role in bridging the information gap between global institutions and civil society organizations (CSOs), especially those representing marginalized communities.

One of the Hub's most notable successes was its ability to distill complex UN discussions into more digestible formats. In real-time, it translated the outcomes and insights from the Summit into language that non-experts could easily understand. This approach ensured that the conversations surrounding the Pact for the Future were inclusive, inviting more participation from underrepresented groups. By making these global discussions accessible, the Hub empowered CSOs and other stakeholders, including those from marginalized and underrepresented communities, to engage with the UN's efforts more effectively.

Reducing inequality was at the heart of the Hub's work. Through live coverage of events like the People's Assembly, which focused on centering lived experiences and priorities from disadvantaged communities, the Hub ensured that the voices of those most affected by global challenges were heard. This not only promoted greater equity in discourse but also pushed forward the idea of people-centered multilateralism. By ensuring that all stakeholders, regardless of background, had the opportunity to engage with and contribute to high-level conversations, the Hub played a direct role in reducing information inequality and amplifying marginalized voices.

Additionally, the Hub's work was closely tied to the theme of intersectionality, highlighting how various forms of inequality, including those based on gender, race, disability, and climate justice, are interconnected. This intersectional approach was especially evident in discussions during the Summit, where the Hub emphasized coalition-building as a means to empower youth and marginalized groups.

Overall, the Coalition's Media and Information Hub fostered an environment where more people, especially from marginalized sectors, could meaningfully engage with the UN's vision for a more equitable future. This transparency and inclusivity directly contributed to reducing inequalities, not just in terms of access to information but also in giving marginalized voices a platform in shaping the global agenda.

## B. Summit of the Future Action Days



As a Communications Associate for the Coalition for the UN We Need, I provided live Twitter coverage of the Summit of the Future Action Days, which was a critical effort in promoting transparency, accessibility, and reducing information inequalities. Over the course of these events, I dedicated 14 hours each day to generating over 300 tweets, translating complex, high-level discussions into digestible insights for a broader audience. This real-time coverage allowed civil society organizations (CSOs), marginalized communities, and stakeholders who were unable to attend the summit in person to follow and engage with the proceedings.

In line with reducing inequalities, my live coverage aimed to democratize access to the UN's ongoing efforts to promote people-centered multilateralism. By breaking down outcomes and dialogues into accessible language, I ensured that individuals and organizations, especially those from underrepresented and disadvantaged backgrounds, could grasp the discussions and feel empowered to engage. This approach reduced the information barriers that often exist in such high-level summits, where technical language and bureaucratic processes can exclude everyday citizens and smaller organizations from understanding or participating.

### C. Peoples Assembly



In addition, my live Twitter coverage of the **People's Assembly** during the Summit of the Future was a direct effort to reduce inequalities by amplifying the voices of marginalized communities and bringing their perspectives into the global governance discourse. The People's Assembly focused on centering the lived experiences of individuals from disadvantaged backgrounds, highlighting the urgent need for policies that address systemic inequities in various sectors, including social justice, economic equity, climate action, and human rights.

By providing real-time updates, I ensured that those who could not attend the summit, including civil society organizations (CSOs) and grassroots movements, had access to critical insights from the assembly. I translated complex discussions into accessible language, making the outcomes understandable for a broader audience, particularly those from marginalized communities. This allowed them to stay informed and engaged with the UN's follow-up to the **Pact for the Future**, a global effort focused on achieving sustainable development goals (SDGs) and promoting inclusivity.

One of the key themes I emphasized in my coverage was the need for **intersectional approaches** to tackling inequality. The discussions at the People's Assembly addressed how various forms of discrimination—such as those based on gender, race, disability, and socio-economic status—are interconnected. By sharing this content on Twitter, I underscored the importance of creating coalitions that can work together to push for more inclusive policies that serve diverse communities.

Through this live coverage, I worked to empower marginalized groups by amplifying their stories and ensuring that their priorities were part of the larger conversation at the summit. This not only reduced information inequalities but also fostered a more inclusive dialogue on how the international community can tackle inequality in a meaningful, people-centered way.

By bringing real-time coverage to Twitter, I contributed to breaking down barriers between global decision-making processes and the communities most affected by them, ensuring they have a voice in shaping the future.

**D. IYC 10**



During the **Youth in High-Level Spaces** panel at **IYC 10**, I emphasized the vital role that young people play in global governance and decision-making processes. I believe it's crucial to create inclusive opportunities for youth, especially those from marginalized communities, to engage meaningfully in these high-level discussions.
